The Refresher Course is designed for practitioners who wish to become re-accredited as a Mediator but have not completed the necessary Mediations or CPD Training to comply with National Mediator Accreditation Standards (NMAS).

The Course will consist of:-

- 3 x One hour pre-recorded Webinars— to be viewed prior to the course
- 2 days face to face training—Thursday 9 and Friday 10 November including Role playing and refreshing the skills of the mediator
- Assessment role playing with accredited coaches and mediators—held on Friday afternoon 10 November
- Additional written Reflection of the assessment role play.

Throughout the program participants will have coaching from nationally accredited mediators to assist them in improving their mediation knowledge and skills. This will also help prepare participants for the national mediator accreditation assessment role-plays.

Please note: Successful completion of the Course does not mean that the participant will be Nationally Accredited. To complete the requirements for National Mediator Accreditation, participants will need to successfully complete an additional written component.
